How Europe Works: Institutions & Law in the EU (ILEU)

Overview

This business law programme is a unique blend of business, law, politics and culture, offering students the chance to undertake a demanding, in-depth study of the European Union (EU) and its legal workings.

Date

28 June – 18 July 2026

Course Content

- European Governance
- EU Foreign Policy and Labour Rights under European Law
- EU Corporate Law

The course programme also includes:

- Study visits to companies
- Module on German culture and society from an intercultural perspective

Course Language

English. Proof of English proficiency (TOEFL iBT 90 or equivalent) is required.

Prerequisites

Upper undergraduate students of law, business and public administration, international relations and related fields (after two years of study) or graduates with good standing.

€ 995 (without accommodation)

- 6 ECTS: Business Law Programme
- 1 ECTS: German culture & society module
