### **NOMINATION & APPLICATION**

Nomination procedure	To nominate your students, please complete the following form <a href="https://forms.office.com/r/W4gJ6bBmQX">https://forms.office.com/r/W4gJ6bBmQX</a>
Deadlines	No nomination deadline, but we do require the completed nomination form BEFORE your students apply.
Application deadlines	Fall/Full Year: May 1 <sup>st</sup> Winter: October 1 <sup>st</sup> Summer: February 1 <sup>st</sup>
Admission requirements	Home university to nominate eligible inbound exchange students. Students must then apply to and be accepted by Dalhousie to officially confirm their exchange at Dalhousie.
Minimum GPA	N/A
Language requirements	English B2
Application details	Dalhousie's Exchange Office will email the student(s) with instructions on when and how to apply to Dalhousie with a copy to the home institution.
Supporting documents	<ul><li>Nomination letter: can be submitted if the student is provided with one, but it is not required.</li><li>Official transcript (PDF file only)</li></ul>
Acceptance to Dalhousie	Students can expect to receive an acceptance letter via email 4-6 weeks after they have applied.



# **ACADEMIC INFORMATION**

Course Registration	After an inbound exchange student has been accepted to Dalhousie, Exchange staff will email the student with information on how to register for courses. The earlier students can apply, the better their chances of getting into their preferred courses.
International Student Orientation	Fall Term: Late August Winter Term: Early January Summer Term: No formal orientation. Students can meet with the Student Exchange Advisor upon arrival.
Semester Dates	Fall Term: September to December (including exams) Winter Term: January to April (including exams) Summer Term: May to August (including exams)
Restrictions	Faculty of Graduate Studies, Dentistry, Law, Medicine, Planning, and most programs/courses in the Faculty of Health are all restricted from exchange students.
Course Load Information & Requirements	A full course load is 5 courses or 15 credit hours per Term.  Exchange students are required to take a minimum of 3 courses per semester but are permitted to take up to 5 courses per semester. Most single term courses are worth 0.5 credits or 3 credit hours.

# PRACTICAL INFORMATION

Accommodation	<b>Residence:</b> NOTE: there is limited residence availability for exchange students. Dalhousie offers a variety of residence styles and sizes – all are conveniently located and offer meal plans. Learn more about <u>Dalhousie residences</u> .
	<b>NOTE:</b> If students are coming to Dalhousie on exchange for the fall term only (September–December), unfortunately there is no space available in residence during this period - see off-campus housing options. Students who come to Dalhousie for the winter term only (January–April) or for a full academic year (September–April) may inquire with the Residence office (residence@dal.ca) directly about availability.
	Off-Campus: There are many off-campus housing options within walking distance or along bus routes and meal plans are also available to non-residence students if you choose to live off-campus. View listings on <a href="Dalhousie's Off-Campus Living website">Dalhousie's Off-Campus Living website</a> , which can also help with their search and provide tips to prepare students for off-campus living. If the stay is longer than 6 months: Students must apply for a Study Permit at the nearest Canadian visa office in their home country. In addition to the study permit, they may be also required to obtain a Temporary Resident Visa (TRV) which gives students permission to enter Canada. It is only required for citizens of certain nationalities. Please check the <u>list of countries and territories whose citizens require an entry visa</u>.

**If the stay is less than 6 months:** Study Permit is not mandatory, but students may have to apply for a Visa or an <u>Electronic Travel Authorization (eTA)</u>.

#### Visa & Residence Permits

For any case, Immigration, Refugees, and Citizenship Canada – IRCC encourages all visiting students to apply for a study permit for the following reasons:

- It allows them to work part-time in Canada. A part-time job can be a great source of income while abroad.
- It is easy to extend if they want to stay in Canada longer. Some students love it here so much they want to stay longer. It is much easier and less expensive to apply for a study permit before they begin studying in Canada, than after
- It allows them to access cell phone plans and other utilities much easier. If they are simply a visitor to Canada, they may not have access to a lot of great utility plans and other business options that students with study permits can take advantage of.

Exchange students must pay the following incidental fees to Dalhousie:

- Dalhousie Student Union DSU International Student Plan: \$750 per year (pro-rated for the duration of a student's exchange)
- DSU Health and Dental Plan: \$500 per year (pro-rated for the duration of a student's exchange)
- Public Transport Pass (UPass): \$160 per year

# Incidental Fees and Health Plan opt-out option

All students at Dalhousie must have valid health insurance for the duration of their studies. The Dalhousie Students' Union (DSU) administers a health and dental plan (all students) and an international student health plan (international students). International students are required to accept and pay for the DSU insurance plans unless they already have comparable health insurance coverage, in this instance, they may be able to opt-out of the DSU insurance coverage. The DSU Student VIP website has information on how to opt-out and what the requirements are.

There are strict requirements in order to opt out. It is important for students to know what is required before purchasing insurance from home as otherwise they risk having to pay for insurance from their home country as well as insurance from Dalhousie.

Note: If students start school in **September**, they are *automatically billed and enrolled in both insurance plans*. If students start school in **January or May**, they are *only enrolled in the International Student Health Plan* and so they must opt-in to the Health and Dental Plan should they wish to have the coverage.
