## HEALTH & TRAVEL INSURANCE

All international exchange students coming to WIT are advised to take out comprehensive health and travel insurance before coming to Ireland. Private health and travel insurance may be obtained either from the students' home country or from an Irish provider.

Students should be advised that participation in the International Exchange programme abroad involves certain inherent risks which the exchange student must assume. The risks associated include, but are not limited to, responsibility for damage to or loss of property, personal illness or injury and death while the exchange student is a participant in the programme.

Although WIT takes all necessary steps to mitigate these risks and to provide assistance in time of need, the student must take responsibility for ensuring personal safety and security during the study placement. The student must assume responsibility for taking out adequate personal travel and health insurance, some of the main providers in Ireland are:

**Module Selection** Exchange students may select modules from the WIT ECTS Module Guides **only**. The WIT ECTS Module Guides can be found on the following webpage <https://www.wit.ie/international/exchanges/non-eu-exchange-incoming-students>

The maximum number of ECTS credits students can study per semester is 30 and the minimum is 15. The majority of modules at WIT are worth 5 ECTS. Modules have between 3-4 hours of classes each week.

**IMPORTANT:** *If students select modules from different programmes and different years' there will be clashes in their timetables. We advise students to discuss this with their academic advisor and to select a number of alternative modules to be approved in case of a timetable clash occurring. Please be advised the timetables are released at the start of the semester.*

There is a 'How to find and use your timetable' tutorial on the WIT website to help students create their specific timetable.

**Academic requirements**

Students must have successfully completed all modules in the sending University and it is the responsibility of the coordinator whom nominates students for exchange, to nominate students that they believe have the ability to successfully complete exchange studies at WIT. Students do not require a specific GPA in order to register on the WIT Student Exchange programme.

**English Language Requirements**

Exchange students are not required to submit proof of their English language proficiency. Partner institutions are expected to select students who have the required standard of English as set out in our inter-institutional agreement.

**English Language Modules for Exchange Students**

WIT offers three English language modules worth 5 ECTS each at the following levels:

- B1
- B2
- C1

**IMPORTANT:** *Please be advised we cannot guarantee classes are scheduled every semester due to resource limitations. If they are scheduled, the student will be advised of this during the induction programme. Places are limited and cannot be guaranteed and are awarded on a first come first serve basis.*

Students can attend **one** level only and they are required to attend **all** 3 hours of classes per week.

**Exam and Assessment Registration**

Students are generally given two weeks from the start of semester before they must submit a "**Course Registration Form**" to the Office for International Relations. This form is provided to our Examinations and Registry Departments to register the student for their exams.

Exam timetables are released between 4-6 weeks prior to the exams.

## VISA REQUIREMENTS

The Office for International Relations at WIT provides information and support to **non-European students** regarding arranging their study permits. We hold a visa workshop as part of our international student induction programme.

If prospective exchange student is a Non-EU citizen, they will require a **Visa Support Letter** provided by the WIT Office for International Relations. To acquire a Visa Support Letter from WIT the student must first complete your online application following the approval of their nomination.
