Academic Dates	Fall 2021: September 8 – December 8 th (exams Dec. 11-21)		
Course Load	Winter 2022: January 4 – April 7 (exams Apr. 11-26) 3-5 courses in a semester - each course meets for approx. 3 hours/week for 13 weeks and is worth 3 credit hours.

Course Registration Period	Registration is completed online beginning April 13 th until September 14 th for Fall term and until January 14 th for Winter Term Register once accepted to SMU, since courses will close for registration once full. Permission from SMU academic advisors is required before registering in courses with pre-requisites.		
3 Eligibility			
Language Requirements	TOEFL iBT 80, IELTS 6.5 or equivalent (test result is <u>not</u> required)		
GPA Requirements	There is no GPA requirement, but pre-requisite courses for a SMU course need a pass at a grade of 65% or higher at the home institution.		
Other Considerations	Not all course options may be available due to insufficient pre- requisites, enrollment limit, etc. Thus, Saint Mary's exchange program may not be suitable for students who need a specific set of courses.

Application Period	Fall 2021: Beginning March 15th (recommended, especially for fall semester-only students applying for on-campus housing) to Late May* Winter 2022: March 15th (recommended) to Mid-September* *Applications are accepted on a rolling basis and past the above periods on an individual basis. Application Materials	 Home Institution Coordinator will: Confirm the number of exchange places available for their institution. Complete the Nomination form Send a PDF copy of the Letter of Permission (see template) to the students, to include in their admission application. Email a scan of official grades in English as a PDF issued by the home institution to global@smu.ca.

5 Insurance				
	The <u>SMU Students' Association (SMUSA)</u> Basic Health, Extended Health and Dental Plans are mandatory, unless the student's alternative coverage arranged through their home institution meets the <u>"Opt-Out"</u> requirement.

Options	Single Student Housing or Senior Apartments			
Application	Apply online with a \$25 application fee. A \$500 residence confirmation deposit via credit card is required when a bed space is offered.			
When to Apply	For Fall 2021: as soon as the student ID is issued upon admissions. For Winter 2022: Early October. Spaces are limited.			
Move-in and Move-out	Move-in is usually 2-3 days before the semester begin. Move out is 24 hours after your final exam.

Payment due dates and payment methods	Course tuition (as applicable), student fees, insurance, and housing & meal plan (mandatory for Loyola and Vanier Single/Double rooms) are paid via the Saint Mary's Self Service Banner account by: • September 17 2021 in Fall semester • January 18 2022 for Winter semester Students can view the Account Summary by Term, and explore the payment methods. CIBC International Student Pay is the most convenient payment methods for international students. Saint Mary's cannot accept credit card payments, however CIBC International Pay allows students to use Visa & MasterCard Debit and Credit Cards, Wire Transfer, etc.	
9 Immigration		
Study Permit	While the <u>Canadian Border remains closed</u> to non-essential travel, all visiting international students require a <u>study permit</u> to travel to Canada regardless of the duration of their stay. When the Canadian Border opens again, all international students staying for less than 6 months will need either <u>an Electronic Traveller Authorization (eTA) or a visitor visa</u> to enter Canada. In addition, students on a two-semester exchange will need <u>a Study Permit</u>
